

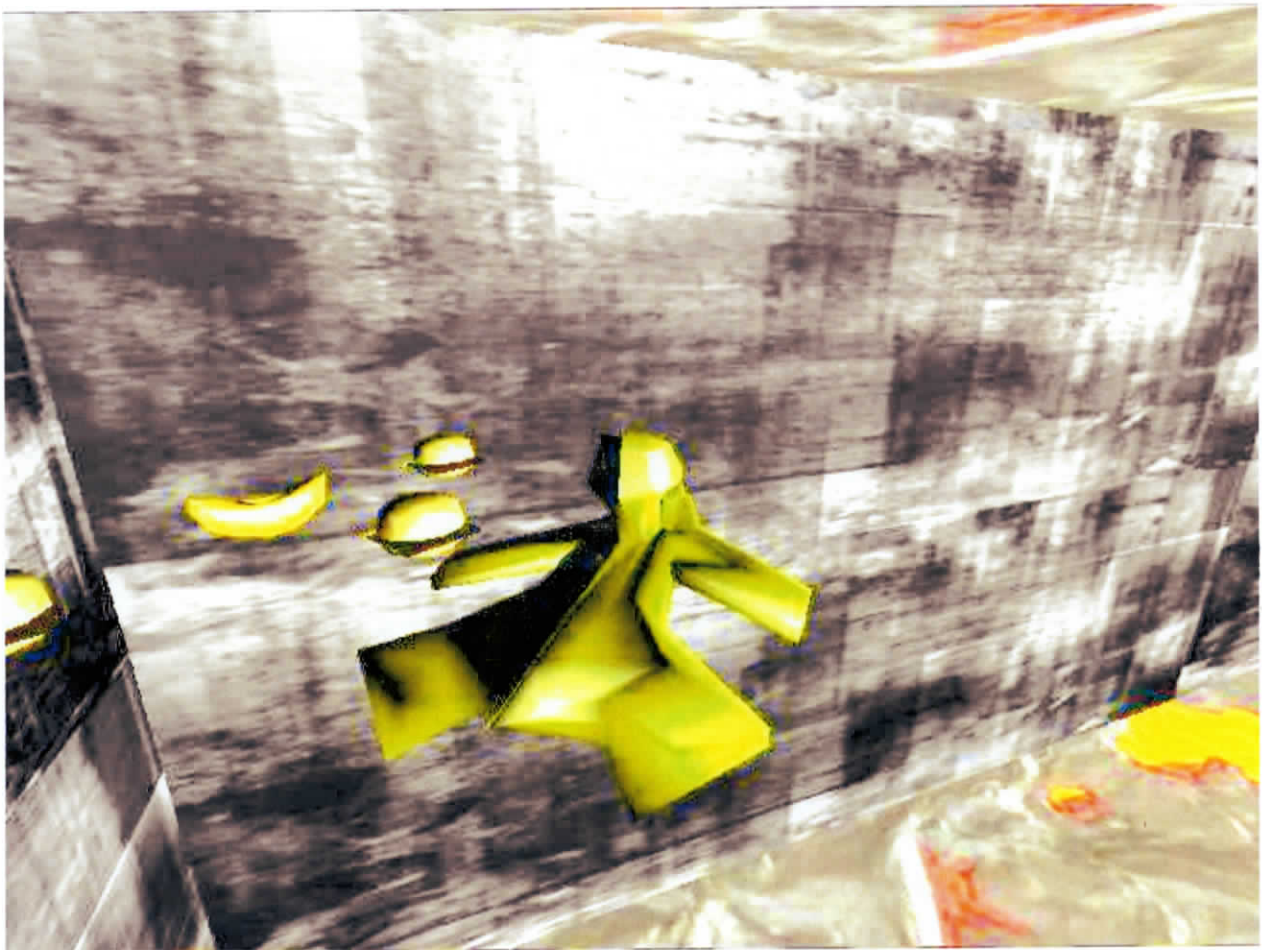

# How to Play

## **Getting started:**

To start the game, put the disc in the disc drive and open "Commbrad". This will take you to the title screen.

## **Starting the Game:**

Once at the title screen, use the arrow keys to select between the options "Start" and "Quit". Once an option is selected, press Enter. If Start is selected, you will continue on to the Act Select screen. If Quit is selected, the game will shut down. Alternatively, you can press ESC at any time to quit the game.

## **Act Select:**

At the Act Select screen, pressing the number keys 1, 2, 3, 4, or 5 will highlight the respective Act number. To begin an Act, highlight it, and press enter. You can also press the B key to highlight the "Back" option. Pressing enter while Back is highlighted will bring you back to the title screen.

## **Act 1:**

Upon selecting Act 1, you will find yourself under control of Commbrad from a side scrolling perspective. During Act 1, pressing the W and S keys will make Commbrad move up and down, respectively, while the A and D keys will make Commbrad move left and right. The goal in Act 1 is to collect the oranges, while avoiding the many cheeseburgers blocking your path. Collecting a cheeseburger will cause you to go up one fatness level, while collecting an orange will bring your fatness level down by one. If your fatness level reaches 8, collecting one more cheeseburger will end the Act, resulting in failure. In the Act, there are two instances in which you will come across a "Health Observation Gate". You can only pass through a Gate if you have collected a sufficient amount of oranges. The first Gate requires a minimum of 3 oranges, while the second requires 6. Attempting to go through the Gate without the required oranges will result in the failure of the Act. To achieve victory, you must pass through the second Gate. Upon doing so, you will be taken to the "Mission Complete" screen, followed by a return to the Act Select.

**Act 2:**

In Act 2, you control Commbrad from a top down perspective. Commbrad is constantly moving forwards. You can use the W and S keys to speed up or slow down, and the A and D keys to move from side to side. The goal in Act 2 is to collect the healthy foods (Oranges, Bananas) while avoiding unhealthy one (Cheeseburgers, Pizza, French Fries). Act 2 introduces the French Fry launchers. Failing to avoid a French Fry launched at Commbrad will raise your fatness level by 1/3. Collecting unhealthy foods will again raise your fatness level by one, while healthy foods lower it by one. Health Observation Gates from Act 1 return. The first gate requires you to collect 4 healthy foods to pass through, while the second requires 7. Upon passing the second gate, you will again be brought to the Mission Complete screen, followed by the Act Select.

**Act 3:**

In Act 3, Commbrad is controlled from a behind-the-back perspective. The W and S keys are again used to move up and down, while the A and D keys control side to side movement. As with the previous Act, the goal is to collect a sufficient number of healthy foods to be able to pass through the Health Observation gates, while avoiding unhealthy foods. Collecting unhealthy foods will raise Commbrads fatness level by 1. If his fatness level reaches 8, the Act ends in failure. The first Health Observation Gate requires that you collect 3 healthy foods to pass, while the second requires 7. After passing the second, you will again be brought to the Mission Complete Screen, followed by the Act Select.

**Act 4:**

Act 4 is controlled from an angled top down perspective. The WASD keys are again used for movement in all directions, while the left and right arrow keys are used to rotate left and right. The goal of Act 4 is to ascend a tower full of various foods. To ascend each level of the tower, Commbrad must collect enough healthy foods to be able to use a teleporter, which will teleport you to the next level of the tower. Each teleporter requires an increasing number of healthy foods to be collected to be used, the first requiring 1 healthy food, the second requiring 2, etc. Collecting unhealthy foods will effect Commbrad in the exact same way as in the last 3 Acts. If Commbrad's fatness level reaches 8, the level ends. When a sufficient amount of healthy foods has been collected, and the final teleporter has been touched, you will be brought yet again to the Mission Complete Screen, followed by the Act Select.

### **Act 5:**

In Act 5, you control Commbrad in a fully 3D environment. You control Commbrad's forward and backward movement with the W and S keys, and his left and right movement with A and D. You can rotate Commbrad left and right with the left and right arrow keys, and you can rotate him forwards and backwards with the up and down arrow keys. You can also make him roll left and right with Q and E. The goal in Act 5 is to defeat the nefarious Dr. Shep. You must collect the bananas so that you may gain ammo needed to defeat Dr. Shep. Each banana supplies you with 3 ammunition. To fire off a shot, press the spacebar. You must hit Shep with 9 shots to defeat him. Dr. Shep will impede your progress by bombarding you with giant donuts. Each donut raises your fatness by 1. If your fatness level reaches 8, you have lost. If you manage to hit Dr. Shep with 9 shots, the Act, and the game, will be completed.

**A:** Move left

**D:** Move right

Act 2 Controls:

**W:** Speed up

**S:** Slow down

**A:** Move left

**D:** Move right

Act 3 Controls:

- W:** Move up
- S:** Move down
- A:** Move left
- D:** Move right

Act 4 Controls:

- W:** Move forwards
- S:** Move backwards
- A:** Strafe left
- D:** Strafe right
- Left Arrow:** Rotate left
- Right Arrow:** Rotate right

Act 5 Controls:

- W:** Move forwards
- S:** Move backwards
- A:** Strafe left
- D:** Strafe right
- Q:** Spin left
- E:** Spin left
- Left Arrow:** Rotate left
- Right Arrow:** Rotate right
- Up Arrow:** Rotate down
- Down Arrow:** Rotate up
- Spacebar:** Fire projectile

# Self Evaluation

## **David:**

For this game, we created all the models represented. We used a program called Blender that allowed us to create three-dimensional characters and use a game engine that was built into the program itself. To create the characters, various tools and features inside Blender had to be learned. Objects were slowly shaped and smoothed by dragging and using other sculpting tools. We added color and other textures to give our creations more artistic detail. The creation of this game required a higher level of artistic ability due to perspective in the advancing mechanics of each level. We hope that the visuals will gain the interest of players and get others to join with them, hopefully educating them about food choices in the process.

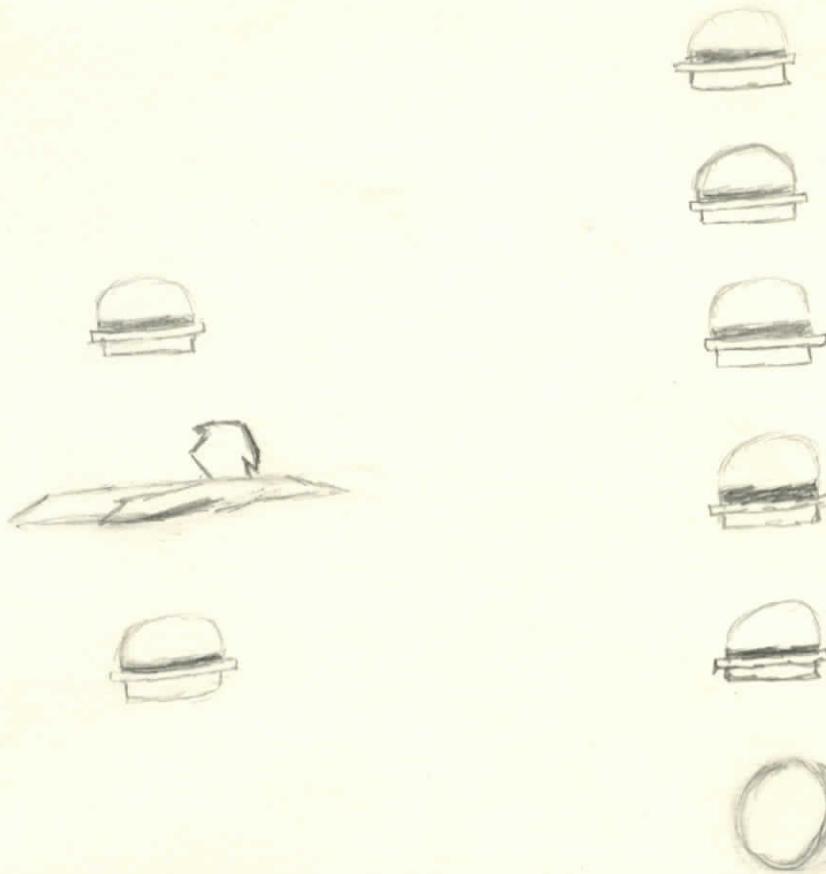
## **Jacob:**

As the game progresses, each level becomes more interesting and mechanically advanced, thus creating a more exciting and compelling gameplay experience. The game can be successfully played directly from a DVD and offers five levels of skill to its players. It is instructional in that the games objective is to educate students to make healthier food choices. While we originally planned to incorporate a mathematical aspect in that actual calories would be calculated, we were limited by time in completing this goal. We hope the skills we learned from this endeavor will open up doors for us to get into some aspect of the game industry.

## Bad logos



Other designers have tried to make their own versions. The following examples have severe shape deformation issues:

- The first designer forgot to add the subtle "backwards leaning" perspective in the logo, the three 'fingers' of the logo have to be of different width.
- The other designers thought it would be fun to make the logo in 3D. This makes it badly recognizable. The logo should remain a graphical '2D' item.
